

TERMS AND CONDITIONS

 - The promotion does not apply to managers, administration personnel and fitters at Point S stores or any person directly or indirectly involved in the organization or running of the promotion or their immediate family members.
 - Bridgestone employees and their authorized distributors/promotional agencies are not allowed to participate in the promotion.
 - The promotion is not applicable to wholesale transactions and is intended solely for retail consumer purchases.
3. PROMOTION ENTRY
 - To qualify, a customer must purchase four (4) new Bridgestone Dueler A/T 002 tyres, size 17 inch or larger, within the Promotion Period
 - The promotion is valid for the first 150 qualifying customers nationwide.
 - Each qualifying customer will receive a cashback reward of R1,000.00 (One Thousand Rand) allocated from the total prize pool of R150,000, distributed evenly across qualifying participants and on a first-come, first serve basis.
